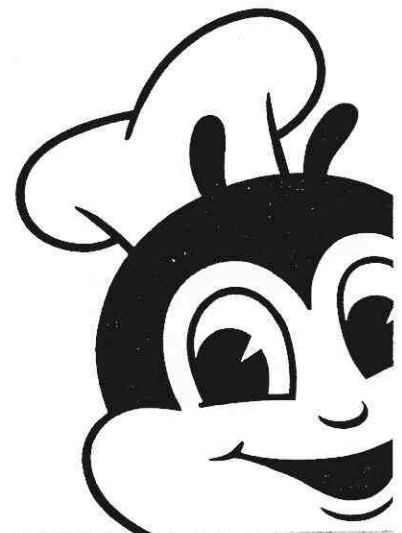

**JFC Discloses Final Purchase Price for "Smashburger" Acquisition**

**Metro Manila, Philippines, January 13, 2016** – *Jollibee Foods Corporation* (PSE: JFC)

Further to its October 13, 2015 and October 27, 2015 disclosures, Jollibee Foods Corporation ("JFC") disclosed today that, in accordance with the post-closing adjustment mechanism under the agreement between its wholly-owned subsidiary Bee Good! Inc. ("BGI") and Smashburger Master LLC ("Master"), BGI paid Master the amount of USD777,494, in addition to the amount of USD99,473,918 that was paid on closing of the transaction. Accordingly, the final purchase price for BGI's 40% stake in the Smashburger® business is USD100,251,412. The purchase price adjustment, as validated by JFC's accounting and tax advisor for this transaction Isla Lipana & Co./PwC, was mainly attributable to higher (than estimated) actual level of cash of SJBFLLC, the parent company of the entities comprising the Smashburger® business.

JFC operates the largest food service network in the Philippines. As of November 30, 2015, it was operating 2,427 restaurant outlets in the country: Jollibee brand 901, Chowking 429, Greenwich 226, Red Ribbon 364, Mang Inasal 456 and Burger King 51. Abroad, it was operating 639 stores: Yonghe King (China) 321, Hong Zhuang Yuan (China) 42, San Pin Wang (China) 59, Jollibee 135 (US 32, Vietnam 69, Brunei 12, Saudi Arabia 10, Qatar 3, Kuwait 4, Hong Kong 1, Singapore 2, Bahrain 1 and UAE 1), Red Ribbon in the US 33, Chowking 46 (US 19, UAE, 20, Qatar 4, Oman 2 and Kuwait 1), Jinja Bar (US) 3. The JFC Group had a total of 3,066 stores worldwide.

JFC also has a 50% interest in joint ventures for the following stores: Highlands Coffee (Vietnam, Philippines) 98, Pho 24 (Vietnam, Indonesia, Cambodia, Korea and Australia) 38 and 12 Sabu (China) 21.
